A tax rate of \$0.2527 per \$100 valuation has been proposed by the governing body of SOUTH LIMESTONE HOSPITAL DISTRICT.

PROPOSED TAX RATE \$0.2527 per \$100 NO-NEW-REVENUE TAX RATE \$0.2627 per \$100 VOTER-APPROVAL TAX RATE \$0.2859 per \$100

The no-new-revenue tax rate is the tax rate for the 2023 tax year that will raise the same amount of property tax revenue for SOUTH LIMESTONE HOSPITAL DISTRICT from the same properties in both the 2022 tax year and the 2023 tax year.

The voter-approval rate is the highest tax rate that SOUTH LIMESTONE HOSPITAL DISTRICT may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is not greater than the no-new-revenue tax rate. This means that SOUTH LIMESTONE HOSPITAL DISTRICT is not proposing to increase property taxes for the 2023 tax year.

A PUBLIC MEETING TO VOTE ON THE PROPOSED TAX RATE WILL BE HELD ON September 26, 2023 AT 3:00 PM AT Limestone Medical Center, Board Room 701 McClintic Dr., Groesbeck, Texas 76642.

The proposed tax rate is also not greater than the voter-approval tax rate. As a result, SOUTH LIMESTONE HOSPITAL DISTRICT is not required to hold an election to seek voter approval of the rate. However, you may express your support for or opposition to the proposed tax rate by contacting the members of the Board of Directors of SOUTH LIMESTONE HOSPITAL DISTRICT at their offices or by attending the public meeting mentioned above.
